

**Title:**

S-1B Products generated without AUX\_RESORB between 10 April 14:00 UTC to 11 April 07:00 UTC 2019

**Description:**

On 10<sup>th</sup> and 11<sup>th</sup> April 2019, S-1B products were processed without Restituted Orbit Files. This induces a minor degradation in the geolocation accuracy of these products.

The identification of impacted products can be done based on the following conditions (all matching):

- Acquisition dates (see below)
- Processing dates (see below)
- Product types (see below)
- No AUX\_RESORB is mentioned in the product manifest
